ACADEMIC SUBJECT: Architecture

RATIONALE:

Architects must have some idea of the way in which architecture is mediated by the immediate professional social and cultural environment in which they work (praxis) and by the wider historical, social and cultural environment in which users and other makers live.

AIMS:

- To develop the students capacity to apply knowledge of history, socio-cultural issues and theories to wider readings of architectural interests as urban and landscape issues
- To develop the student's capacity for the use of text and illustration.
- To encourage students to deepen their awareness of historical, social, cultural and theoretical issues and the application of these to urban and landscape issues.

INTENDED LEARNING OUTCOMES:

*100% of the assessment will be by **coursework** to allow essay writing as the mode of assessment and include feedback to the students during the semester interactively with seminars/lectures.*

CONTENT:

Students will collate and collect a portfolio of urban and rural ideas in the form of two A4 page collages of images and text at various scales for a concept (given in the assessment criteria section below (eg: new urbanism, the garden city, radial city, man about town, drugs and city etc. etc.)).

***Essay Title: The Socio-Cultural Vortex**

Summary ARC306B2

Architects must be able to interpret and explain the differences in designing for the detailing of buildings through to designing for urban and/or rural as knowledge linked to individual, historical, social cultural and functional manifestations of ideas in the form of utopias and/or ideologies as well as just pragmatic answers to need.

The emphasis on interpretation and concepts of identity will be key. Each student will produce a short essay on contemporary subjects that inform and complicate design in all interpretations of 'difference' indicating clearly their use of reference works and opinions that they use in forming their approach. Students will be expected to indicate personal preferences in their use of references and justify that selection in text so that a casual reader could reasonably be able to discuss their choices with them.

ASSESSMENT CRITERIA

Appendix A:

Portfolio collection of concepts in urban and rural landscapes

Each student is required to carry out the following procedure:

Your task is to locate and structure information in the form of image and text so as to create two sheets of A4 paper relating to a concept of urban and rural design.

The point of the exercise is to see how clearly you can refer to a design concept and also provides a diverse resource for yourself if your work was ever to become part of an exhibition for example or put on the web

Assessment criteria for this task is made available below.

This coursework must be completed by week 10 and counts as 15% of the total marks for this module

This year you are to create two A4 paper graphic collages to show the possibilities of drugs being given the same urban usage as alcohol – consider for example the familiarity with beer and good beer, wine and fine wine, spirits and the cultural significance in terms of class with Armagnac and Cognac as digestifs. You will probably need to look up terms on the web and you may find the following book useful:

Appendix B:

Essay assessment criteria and requirements for submission

the essay is to be **3000** words and must include illustrations/graphics.

The Socio-Cultural Vortex

Each student must show that they know that ideologies and global influences may conflict in a complex and sometimes paradoxical yet discernable manner to the identities of indigenous peoples (a term that is in itself contentious when compared to humanity as a whole) in the matter of urban design, art, identity, landscape design and architecture.

The essay is a chance to explore comments by architects and groups of architects that seek to extend beyond the boundaries of one building to city and urban design or contemporary thinking about such matters as well as the thoughts and discoveries of other individuals who may not be architects but you need to remember that you are studying architecture!

In addition you are expected to find one other commentator/critic commenting on the work of your selected architect/group/ concept/ author (note the inclusion of author which means that the author may not necessarily be an architect) etc etc. That commentator/critic should have some credibility in the architectural community – say, a journalist or historian or theorist of some kind - who can be cited - referred to. You are expected to integrate this second critical comment into your essay merging

1. your architect/group/author whatever and their statement
2. your own opinions
3. your second commentator's comments/opinions

The point of the exercise is to consider how other individuals comment on the fact that what people say they try to do may or may not be achieved or even possible when they try to manifest their thinking by printing or writing or televising especially when suggesting that such thoughts may be translated into architectural practices.

Many of you will experience difficulties because you have rarely thought of the world as something that you refer to using language in such a way that the language is not simply a reference to reality but another phenomenon that adds itself to the relationship you have to the world in such a way that you can imagine other people having a similar relationship so long as they consider the phenomena you use in language to license the same or similar feelings as you intend them to produce. As a simple example if I say I like eating, you may agree but not to the exclusion of all else, if I say I like eating frogs legs, you may not agree but you may agree that it is not impossible to actually like eating frogs legs. Putting the words together have differing results that are not entirely to do with the words alone since some do and some don't like the same construct 'eating frogs legs'. We can take the same simple example set against say the golden section. I do not like the golden section is meaningless without an interpretation of what those words might mean and that requires a lot of interpretation as to what each individual understands by the words and whether or not they license some innate connection to a spirit world or nature or mind or forbid it as metaphysics. The essay is a chance for you to try to understand this simple example of saying and liking and sharing, using some architectural stuff whenever possible.

This essay will count 85% towards the total marks for this module
